To <b>deter</b> further rebellions and to show the Saxons who was boss he <b>murdered villagers, burned homes and crops</b> . This cruel treatment was called the <b>Harrying of the North</b> .	19	<b>Sherriff</b>	‘high reeve’ in French could command peasants to help chase criminals in his posse.	34	<b>Mutilation</b>	Continues under the Normans for repeat offenders and poachers. Whipping added.
			20	<b>1215 –</b>	<b>Trial by Ordeal</b> banned by the Pope.	35	<b>Humiliation</b>	An addition to stocks and pillory, carting and ducking added for minor crimes
			21	<b>1300 sanctuary</b>	claimed by criminals on the run when the reached a church. They could stay for 40 days after which they had to face trial or go into exile.	36	<b>Execution</b>	Hanging, used much more frequently by the Normans compared to Saxons. Punishment for treason and murder.
			22	<b>1300 Benefit of clergy</b>	Priests would not be executed . To prove you were a priest you had to recite a verse from the bible. So criminals learnt verses off by heart to avoid execution by hanging. This was known as the ‘neck verse’.			
6	<b>Outlaw</b>	A criminal who escaped capture and went ‘on the run’ committing many crimes over a long period of time. E.g. the <b>Folville Gang</b>	23	<b>1300 Church courts</b>	heard cases involving priests. These courts gave <b>much less harsh sentences</b> than normal courts	37	<b>Punishment factors</b>	
			24	<b>1300 quarter sessions</b>	Held in each county four times a year, heard serious cases by ordinary people e.g. murder. Judges were <b>Justices of the Peace</b> – the most powerful local lord.	38	<b>Purpose of punishment: deterrence, retribution or reform?</b>

Early Modern Crime		
1	<b>Petty theft</b>	In <b>Early Modern</b> England 75% of all crime was theft of small items e.g. food, livestock.
2	<b>Heresy – not following the religion of the monarch</b>	<ul style="list-style-type: none"> <li>1534 - Act of Supremacy. English law that made Henry VIII the “Supreme Head of the Church of England.”</li> <li>Edward VI made protestant changes</li> <li>Mary I : Bloody Mary, executes nearly 300 Catholics.</li> <li>1559 Elizabethan Settlement. Heresy convictions decline as religious tolerance increased</li> <li>1640s. Cromwell replaced heresy laws with crime of blasphemy.</li> </ul>
3	<b>Treason</b>	<ul style="list-style-type: none"> <li>1534 - Act of Supremacy. English law that made Henry VIII the “Supreme Head of the Church of England.”. Anyone who does not recognise his marriage to Anne Boleyn was executed for treason.</li> <li>Elizabeth executes catholic Plotters e.g., Duke of Norfolk, for treason.</li> <li>1605. James I increased fines paid by Catholics. Guy Fawkes and Gunpowder Plotters arrested for treason.</li> </ul>
4	<b>Witchcraft</b>	<ul style="list-style-type: none"> <li>1597; James I book ‘Demonology’ warns of the dangers of witchcraft</li> <li>1604: communicating with the devil made punishable by death</li> <li>1640s: Mathew Hopkins the witch finder general tortures women into confessing to witchcraft.</li> </ul>
5	<b>Vagabonds-unemployed and homeless</b>	<ul style="list-style-type: none"> <li>1536 Henry VIII closed the monasteries</li> <li>1567 Thomas Harman published ‘A Warning for Vagabonds’. Spread panic about criminals vagabonds e.g. counterfeit crank pretended to be sick, Tom O’Bedlam pretended to be mad.</li> <li>1570s very poor harvests led to increased food prices</li> <li>Increased population means more unemployed and hungry</li> </ul>

Early Modern: Punishment		
22	<b>Continuity</b>	Humiliation punishments, fines and corporal punishments such as whipping
23	<b>Burning at the stake</b>	Punishment for heresy
24	<b>Hanged drawn and quartered</b>	Punishment for treason. Hanged for a minute, then disemboweled and castrated, Organs were burnt on a fire. Then victim chopped into 4 pieces.
25	<b>1531 Vagabonds Act –</b>	undeserving vagabonds punished by whipping, deserving vagabonds given permission to beg by Justices of the Peace
	<b>1547 – Vagabonds Act</b>	Vagabonds punished by being enslaved for 2 years
26	<b>1601 The Poor Law</b>	Local parishes could <b>raise money by taxes to pay for helping the deserving poor. Undeserving poor</b> e.g. vagabonds were sent to ‘ <b>Houses of Correction</b> ’ and put to work
27	<b>1610 –</b>	<b>Transportation to America. Criminals were transported for 7 years, 14 years or life. Had to complete hard labour on farms or building roads.</b>
28	<b>1688</b>	number of <b>capital crimes</b> increased from <b>11 to 50</b> . Start of what Historians refer to as the <b>Bloody Code</b>
29	<b>execution</b>	For serious crimes like <b>murder, witchcraft</b> , treason, counterfeiting money, rape, piracy, arson of a dwelling house or barn with corn in it, highway robbery, stealing from work, horse theft, robbing churches and burglary

They increased scientific experiments and found scientific explanations for things once considered the w</li> </ol>	13	<b>1749 Bow Street Runners</b>	<ol style="list-style-type: none"> <li>Set up by the Fielding Brothers who were magistrates at Bow Street Court</li> <li>In the middle of the eighteenth century London’s population increased and there was an increase in crime.</li> <li>The Bow Street patrolled a small area of London.</li> </ol>	21	<b>Transportation</b>	<ol style="list-style-type: none"> <li>1776 changes to Australia because of American Independence</li> <li>1857 Transportation abolished</li> </ol>
3	<b>Highway Robbery</b>	<ol style="list-style-type: none"> <li>Highwaymen were armed with pistols and travelled on horseback. They forced carriages to stop and robbed the people inside of their valuables.</li> <li>Famous highwaymen like Dick Turpin were often seen as heroes even though they committed violent crime. This was because highwaymen targeted the rich and their crimes were romanticised in cheap newspapers for the masses.</li> <li>By 1830 highway robbery had disappeared because people began to travel by train.</li> </ol>	14	<b>1829: Metropolitan Police Act</b>	<ol style="list-style-type: none"> <li>Home Secretary Robert Peel created the first professional police force to cover the whole of London in 1829</li> <li>There were economic problems in 1826 that led to an increase in petty crime.</li> <li>The Metropolitan Police constable patrolled a set route, called a <b>beat</b>, several times during his shift.</li> </ol>	22	<b>Prison Reform</b>	<ol style="list-style-type: none"> <li>1774 Gaol Act. Influenced by the ideas of John Howard. Improved food and paid prison guards</li> <li>Elizabeth Fry campaigned for improved conditions at Newgate Prison. Trained women in sewing and introduced church services very Sunday.</li> <li>1823 Gaol Act Robert Peel was influenced by Howard and Fry Separated men, women and children into different prisons and appointed prison inspectors.</li> <li>1842 Pentonville prison. Built on Howards idea of separate system and useful work. Each prisoner had their own cell and was trained in a job e.g. weaving.</li> <li>1860. Increased crime led to harsher prisons and the silent system with hard labour. Prisoners silent at all times and completed pointless work like treadmill, the crank and picking oakum.</li> </ol>
4	<b>Smuggling</b>	<ol style="list-style-type: none"> <li>Smugglers brought goods into Britain from abroad without paying tax</li> <li>goods they smuggled were legal but expensive e.g. tea, sugar, brandy and tobacco.</li> <li>For many people smugglers were heroes for providing cheap luxuries. Even though some, like the Hawkhurst Gang were violent criminals. Many people bought goods from smugglers- even MP’s!</li> <li>When taxes were cut in the 1840s smuggling decreased.</li> </ol>	15	<b>1856 Police Act</b>	<ol style="list-style-type: none"> <li>Compulsory for every city and county in England to set up a professional police force like the Metropolitan Police</li> </ol>	23	<b>1830s</b>	Humiliation and corporal punishments abolished (except in prisons)
5	<b>1834 Tolpuddle Martyrs</b>	<ol style="list-style-type: none"> <li>In 1834, in Tolpuddle, Dorset a group of farm workers formed a trade union to protest about low wages.</li> <li>The men were convicted of taking secret oaths and sentenced to 7 years transportation. T</li> <li>hey were mass protests against their treatment and they were pardoned in 1836.</li> </ol>	24	<b>1868</b>	Last public execution	24	<b>1868</b>	Last public execution
